STATEMENT OF PURPOSE:

The purpose of these Standards is to establish minimum requirements for the training of apprentice body piercers in accordance with the Board for Barbers and Cosmetology Body Piercing Regulations.

FORWARD

Recognizing the necessity for the development of skilled and efficient practitioners in the profession and to establish procedures for the training of apprentices as required by the Virginia Board for Barbers and Cosmetology, these Standards have been developed as a guide for licensees seeking approval to train apprentices.

BOTH THE APPRENTICE AND THE SPONSOR ARE TO RESPONSIBLE FOR READING, UNDERSTANDING, AND COMPLYING WITH THE BODY-PIERCING APPRENTICESHIP STANDARDS. FAILURE TO COMPLY WITH THESE STANDARDS MAY RESULT IN A MONETARY PENALTY OR LOSS OF YOUR LICENSE.

1. DEFINITIONS

“Apprentice” means a person who is engaged in learning and working in the profession of Body Piercing under these Standards, and who is in written agreement with the sponsor providing for his/her training in accordance with these Standards of Apprenticeship.

“Apprenticeship Agreement” means a written Master Agreement, referenced on the apprenticeship action form. This constitutes an agreement between the apprenticeship sponsor approved by the Board and the apprentice.

“Apprenticeship Sponsor” means an individual approved to conduct body piercing apprenticeship training who has met the qualifications in 18 VAC 41-50-70 of the Board’s Body-Piercing Regulations and who assumes full responsibility of the apprentice.

“Board” means the Virginia Board for Barbers and Cosmetology.

“Body Piercer” means any person who for remuneration practices Body Piercing.

“Body Piercing” shall mean any person licensed under Chapter 12 of Title 54.1 of the Code of Virginia who for remuneration penetrates the skin of a person to make a hole, mark, or scar, generally permanent in nature.

“Body-piercing salon” means any place in which Body Piercing is offered or practiced.

“Standards of Apprenticeship” means this entire document including these definitions.

“Supervision” means the ongoing process performed by a supervisor who monitors through the inspection, critical evaluation, and direction of the performance of the apprentice and provides regular, documented, guidance and instruction with respect to the skills and competencies of the apprentice.

“Supervisor” means a licensed body piercer who assumes responsibility for the education and training activities of the apprentice.

2. POLICY STATEMENT AND QUALIFICATIONS

A. Policy Statement

On or after the date these Standards are adopted, it shall be the policy of the sponsor that all apprentices shall be governed by the terms of these Standards of Apprenticeship.

B. Qualifications for Apprenticeship

1. Be at least 16 years of age.
2. Be physically able to perform the work.

3. CREDIT FOR PREVIOUS EXPERIENCE

An apprentice may be allowed credit on the term of apprenticeship for that portion of experience, whether with the sponsor or elsewhere, which is equivalent to that which he/she would have received under these Standards. This credit is subject to the approval of the individual sponsor. The maximum to be allowed an apprentice for previous experience as a body piercer is 500 hours.

4. APPRENTICESHIP AGREEMENT

- A. The apprentice (and if a minor, the parent or guardian) shall sign an Apprenticeship Agreement, which shall also be signed by the sponsor and filed with the Board.
- B. This Apprenticeship Agreement shall contain a clause making the terms of these Standards a part of said agreement. Therefore, each apprentice (and if a minor, the parent or guardian) who enters into an Apprenticeship Agreement shall be given a copy of these standards before the agreement is signed.

5. TERM OF APPRENTICESHIP

The term of apprenticeship shall be 1,500 hours of theory and practical training.

6. RESPONSIBILITIES OF THE APPRENTICE

- A. The apprentice must obtain an apprentice certification card from the Board. The card must be posted in the apprentice's work area and shall be accessible and visible to the public.
- B. Failure for non-display or an expired card may result in immediate termination from the program and/or a fine by the Board for both the apprentice and sponsor. An apprentice having an invalid card may result in immediate dismissal from the program.
- C. The apprentice agrees to be punctual and regular in attendance and proper in conduct; he/she agrees to apply himself/herself in the practices of his/her profession.
- D. The apprentice agrees to keep a daily record book of work experiences and techniques practiced while in training and to keep such record book at the place of training for review by concerned parties.
- E. The apprentice agrees to abide by all regulations promulgated by the Virginia Board for Barbers and Cosmetology concerning apprentice body piercer.

7. RESPONSIBILITIES OF APPRENTICESHIP SPONSOR

The responsibilities and duties of the apprenticeship sponsor shall include:

- A. Ensuring that the apprentice has obtained a body-piercing apprentice certification card from the Board, and that the card is posted in the apprentice's work area accessible and visible to the public.
- B. Failure for non-display or an expired card may result in immediate termination from the program and/or a fine by the Board for both the apprentice and sponsor. An apprentice having an invalid card may result in immediate dismissal from the program.
- C. The apprenticeship sponsor shall maintain a current body piercer license issued by the Board;
- D. Ensure that the supervisor of the apprentice holds a current body piercer license issued by the Board;
- E. Providing instruction to ensure that the apprentice obtains a working knowledge of the work performances outlined in the Board's Apprenticeship Training Program.

- F. Ensuring that the apprentice is under the direct supervision of a licensed body piercer while performing any procedure(s) on a patron.
- G. Ensuring that the apprentice is given instruction in safe working methods in each operation as it is encountered throughout the term of apprenticeship.
- H. Conducting and documenting a monthly review and assessment of the apprentice's aptitude, skill and progress.
- I. Maintaining adequate records pertaining to the progress of each apprentice to include documentation of suspension or termination if applicable.
- J. Providing the Board with written notification within seven days of the suspension or termination of an apprentice.
- K. Such other duties as may be involved in developing and maintaining an effective program of apprenticeship.

8. APPRENTICE SPONSOR RATIO

The ratio of apprentices to sponsors shall be two body-piercer apprentices for every one apprenticeship sponsor.

9. SCHEDULE OF WORK PERFORMANCES

- A. The apprentice shall be given instruction and work experience in all branches of Body Piercing listed in the work performances which are recorded on the Training Program Outline contained in these Standards.
- B. The work experience does not need to be performed in the precise order listed, nor do the scheduled number of any operations need to be continuous to permit the flexibility necessary for the normal business operation of the salon.

10. RELATED INSTRUCTION

- A. Each apprentice under these Standards shall enroll in and satisfactorily complete the required related instruction as prescribed by the Virginia Board for Barbers and Cosmetology.
- B. Credit for related instruction received prior to entering apprenticeship shall be coordinated with the Board Administrator. Satisfactory program completion is a mandatory part of the total program for the individual apprentice.

11. PERIODIC EVALUATION

The progress of each apprentice's job performance and related instruction shall be subject to a periodic review. Should a review reveal a lack of interest or ability on the part of the apprentice, the apprentice will be informed of the deficiency and may be placed on probation for a sufficient period to determine improvement or failure. At the end of the probationary period, if the apprentice has not shown acceptable improvement, the apprenticeship may be suspended or revoked. The sponsor will provide written notice of the final action taken to the apprentice and the Board.

12. CERTIFICATE OF COMPLETION OF APPRENTICESHIP

- A. Upon completion of the apprenticeship training, the sponsor shall review the apprentice's progress record for the training period. If the results of this review indicate the apprentice is now a candidate for the Board's examination, the sponsor shall sign the Apprentice Completion Form. The properly signed Apprenticeship Completion Form shall be submitted to the testing vendor with the Body-Piercer Examination and License Applications. A Certificate of Completion shall be prepared by the Apprenticeship Sponsor.
- B. Completion of the apprenticeship program shall qualify the apprentice to apply to the Board to take the Board for Barbers and Cosmetology Body Piercer Licensing Examination.

13. RESPONSIBILITIES OF BODY-PIERCING SALONS FOR APPRENTICE TRAINING

Upon receipt of a request for designation as an Apprenticeship Sponsor, the individual's eligibility will be determined based on the criteria established in the Board's Regulations. The salon where the apprenticeship training will be provided must also be in compliance with the Board's Regulations. The salon shall meet the following standards:

- A. The salon must have a current license issued by the Board and a local business license if applicable;
- B. The salon shall maintain full compliance with the Board's Regulations;
- C. The salon shall have a work station for each apprentice where a sign will be posted in a conspicuous manner which indicates that the person performing the services is working as an apprentice in training.

14. TRANSFER OF APPRENTICES

If a sponsor is unable to carry out the required training, the apprentice may be registered with another qualified sponsor in accordance with Section 3 of the Apprenticeship Standards.

15. RELATIONSHIP OF STANDARDS TO BODY-PIERCING REGULATIONS

Nothing in these Standards shall be interpreted in a manner inconsistent with existing Body-Piercing Regulations of the Virginia Board for Barbers and Cosmetology.

16. MODIFICATIONS

These Standards may be modified, if desired, but any such modification must be approved by the Board. Such modification shall not alter or affect apprenticeship agreements in effect at the time of modification without the consent of all parties affected.

APPRENTICESHIP TRAINING AND PERFORMANCE REQUIREMENTS

1500 Total Apprenticeship Training Hours Required

- A. 350 hours shall be devoted to theory pertaining to sections 1, 2, 4, 5, 6, 7, and 9 below.
- B. 150 hours shall be devoted to theory pertaining to section 3 below.
- C. The remaining 1,000 hours shall be devoted to practical training and the following performances pertaining to sections 8 and 10 below.
- D. An approved body-piercing apprenticeship program may conduct an assessment of an apprentice's competence in the theory and practical requirements for body piercing and, based on the assessment, give a maximum of 500 hours of credit towards the requirements in sections 1, 2, 4, 5, 6, 7, 8, 9, and 10 below.

No credit shall be allowed for the 150 hours required in section 3 below.

1. Microbiology
